This is a courtesy copy of the District review. Official comments for Individual NPDES Construction Permits must be compiled and issues by the Department of Environmental Protection, Southeast Regional Office. They conduct the review of the PCSM Plan.

- 1. The slope length is exceeded to the 12" CFS along the center portion of the Western Boundary, or provide downslope berms for inlets running through the center of the site.
- 2. Please describe and label best management practice around top-soil stock pile.
- 3. The limit of disturbance should include compost filter sock and inlet protection.
- 4. The area noted as being protected from earth disturbance has been delineated. It should also describe the reason this is necessary.

- 5. Please illustrate on plan, and provide a design detail for a Rock Filter around the existing basin outlet.
- 6. Please provide a specification for stabilization with stone and add appropriate notes to the stabilization specifications.
